OFFICE ORDER

The Governor of Punjab is pleased to constitute the Collegium of the Punjab State Information Commission to look into the complaints received in the Commission directly or in reference from any other authority relating to conduct or behavior (other than for transfer of cases from one Bench to another), in respect of the State Information Commissioners.

- 2. The Collegium shall be as under :-
 - 1) Sh.R.I.Singh, Chief Information Commissioner, Punjab.
 - 2) Sh.P.K.Verma, State Information Commissioner.
 - 3) Sh.Surinder Singh, State Information Commissioner.
- 3. The above said Collegium will function till 15.5.2011 because of the fact that S/Sh. P.K.Verma and Surinder Singh i.e. the senior most State Information Commissioners shall be superannuating w.e.f. 16.5.2011(AN).
- 4. From 16.5.2011 to onwards the following Collegium shall function:-
 - 1) Sh.R.I.Singh, Chief Information Commissioner, Punjab.
 - 2) Sh.P.P.S.Gill, State Information Commissioner.
 - 3) Sh.Kulbir Singh, State Information Commissioner.
- 5. However, where any complaint is against any member of the Collegium, the concerned member shall not sit in the meeting of Collegium to consider that particular complaint. The next senior most Commissioners shall be co-opted as member of the Collegium for purposes of that particular meeting. The Collegium shall act as a recommendatory body and its proceedings shall be forwarded to HE Governor of Punjab for such appropriate action as he may deem fit. The mechanism of the Collegium could also be used for consultation by H.E. Governor, Punjab, if he so chooses.
