(To be read in continuity with order dated 16.3.2023, 20.4.2023, 19.6.2023, 21.8.2023, and 9.10.2023)

1. The RTI application is dated **18.8.2022** vide which the appellant has sought **information regarding chargesheet against Dr. Rajdeep Kaur**, as enumerated in her RTI application.
