The respondent-PIO states that he has brought the remaining information duly authenticated including copies of receipt book, pattanama etc. With the supply of this information, nothing has been kept which could be supplied to him according to his application under the provisions of RTI Act, 2005.

4. After hearing both the parties and going through the record available on the case file, it is found that no explanation has been received from the respondent-PIO. He is again directed to file his explanation for withdrawal of imposition of penalty before the next date of hearing failing which it will be presumed that he has nothing to say and exparte decision will be taken. The complainant is advised to get the information from the respondent-PIO and revert back to the authorities in case of deficiencies and on receipt of deficiencies from the complainant, the respondent-PIO is directed to remove the same before the next date of hearing which is fixed for 14.1.2020 at 3.00 P.M. to be heard through Video Conference Facility available in the office of the Deputy Commissioner, Ludhiana.
