The case was last heard on **30.10.19**.

2. Both parties are present. The respondent PIO, who was issued a **Show Cause Notice** at the last hearing on 30.10.19, is represented by Jagdev kaur, APIO-Cum-Senior Assistant. She has submitted that the letter sanctioning the release of the balance gratuity to the appellant has been issued. An attested copy of the letter was handed over to the appellant.

3. Prior to this, the respondent PIO in a letter dated: 5.11.19, also informed the Commission that as directed in its earlier order on 19.9.19, a **Compensation of Rs. 5,000/-** has been paid to the appellant. The appellant also confirmed this in a letter dated 8.11.19.

4. The appellant has expressed his gratitude and has stated that he is satisfied with the information furnished. There is no further cause for action and this appeal case is herewith **CLOSED**.
