First Appeal was filed with the First Appellate Authority (FAA) on **24.3.2023** and Second Appeal was filed in the Commission on **11.5.2023** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first Hearing in the Commission on **14.12.2023**.

2. The appellant is absent without intimation. The respondent PIO-cum-SSP Amritsar Rural, has vide Letter No. 445 Dated 7.11.2023, to the Commission, stated that the cited complaint was misplaced by ASI Kuldeep Singh when he was posted at Police Station Jandiala Guru. Accordingly, a departmental enquiry was initiated against said ASI, who retired on 31.5.2023 and subsequently passed away from a sudden heart attack. Thereafter, the departmental enquiry was closed.
