5. Sh. Chander Parkash, Draftsman-cum-APIO office of M.C., Ludhiana, who appeared on behalf of the respondent PIO in today's hearing, states that the requisite information has already been supplied to the appellant. He also submits a copy of reply dated 28.03.2023, which is taken on record.

6. After perusing the case file, it is ascertained that the information sought by the appellant is lying with PIO office of MC, Ludhiana.

7. I have relied upon the judgement passed by Former SIC Sh. Yashvir Mahajan in AC No's 217, 218, 219, 220 of 2017 titled as Amarjit Singh Dhamotia Vs PIO O/o Commissioner, MC, Ludhiana dated 05.04.2017as under:-

“ The Commission finds that it is the duty of the Commission to see that such blatant misuse of RTI act should not be allowed further and such situation needs to be appropriately dealt with to secure the faith of the public in this “ Sun shine Act” and remove obstacles in functioning of public authority which would eventually prevent public authority from focusing on transparency. His act of running riot with filing repeated applications seeking inane and voluminous information has become counter-productive of public interest. The Commission cannot allow such fishing operations of the appellant. We see his acts as a misuse rather abuse of the RTI Act with unsavoury motives. The cases in hand are found to be vexatious and not bonafide in the quest to ensure transparency and accountability. Dealing with such applications surely is impacting the resources of the Public Authority adversely. The Commission accordingly disposes all the appeals in hand in terms of Section 7 (9) of the RTI Act and allows the Public Authority to ignore his applications in future.”

8. In view of the aforesaid, I am of the view that it is a complicated case and requires adjudication by the Larger Bench. Accordingly, this case-file be sent to the Deputy Registrar for further appropriate action.
