This case was last heard on 22.10.2019 and was adjourned for today with the direction to the Block Development and Panchayat Officer-cum-PIO, Gurdaspur, to be present, **in person**, on the next date of hearing along with the affidavit clarifying the reasons for not supplying the information within time as stipulated under the RTI Act, 2005.

2. The brief facts of this case are that on 12.09.2019, a show cause notice was issued to the Block Development and Panchayat Officer-cum-PIO, Gurdaspur to explain in a duly attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to maximum of Rs. 25,000/- till the complete information is furnished, be not imposed under Section 20(1) of the RTI Act, 2005 on him for causing willful delay/ denial of information to the RTI applicant and why the compensation be not awarded to the appellant under Section 19(8)(b) of the Act for the detriment suffered by him.

3. Today, on 17.12.2019, he is again absent. It is strange that despite issue of so many notices to attend the court but the respondent-PIO is defying the orders of the Commission. It also transpires that the sought information has also not been supplied till date. It is clear that he does not have any respect for the statutory institution. The Commission cannot take it lying down. The matter has to be taken to a logical end. While exercising its authority under Section 18(3)(a) of the RTI Act, **aailable warrant** is issued against the Block Development and Panchayat Officer-cum-PIO, Gurdaspur (By Name) with the direction to the Senior Superintendent of Police, Gurdaspur, to serve it on him to appear along with entire relevant record before the Commission on **04.02.2020 at 12.30 PM** so that the requisite information can be arranged to be furnished to the information seeker and appropriate action is taken on the show cause notice issued to him.
