- After hearing both the parties and examining the case file, appellant is advised to visit the respondent's office on 20.12.2019 at 11.00 AM to inspect the official record. Respondent PIO is directed to make sure that appellant has inspected the official record as per his RTI application and supply the pending information to the appellant on his visit as per the RTI Act.
- 5. Both the parties are advised to represent this case in person or through their representative(s) on the next date of hearing to clear the facts of this case.
- Matter is adjourned for further hearing on 04.02.2020 at 11:30 AM 6.
