The complainant/applicant has no evidence to prove that Satguru Kabir Sabha (Regd.), Jalandhar is a public authority as defined under Section 2(h) of the RTI Act, 2005.

The above said Sabha is not controlled or financed by the Government. So, it is not a public authority rather it is a private institution and the Right to Information Act, 2005 does not apply on it. So, the present complaint case is **disposed of and closed.**


