This order may be read with reference to the previous order dated 26.10.2020 vide which the penalty amounting to Rs.5000/- was imposed upon Sh. Paramjit Singh, Panchayat Secretary and the present Block Development and Panchayats Officer Ms. Manjinder Kaur, Block Development and Panchayats Officer was also issued a show cause notice that why a compensation may not be awarded to the appellant in this case. Also, with the directions to supply the complete information, the case was adjourned for today i.e. 17.12.2020.

- 2. The appellant states that he is not satisfied with the information being supplied by the respondents. However, the Block Development and Panchayats Officer, Ms Manjinder Kaur requests for the short adjournment of the case and assured that the complete information will be supplied to the appellant.
- 3. The perusal of the file shows that in this case, application for information was filed on 15.05.2019 but after lapse of more than one year, incomplete information is being given to the appellant. It is, thus apparent from the response of the respondent-PIO that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.
- 4. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 10000/- (Rupees ten thousands only) by way of compensation to the appellant. This amount shall be payable to the appellant from the State Exchequer before the next date of hearing.
- 5. The Public Information Officer-cum-Block Development and Panchayats Officer is also directed to supply the point wise complete information to the appellant before the next date of hearing.
