ORDER

This order may be read with reference to the previous order dated 18.11.2019, in which it is mentioned that both the parties were absent and the respondents were directed to take appropriate action on his RTI application and intimate regarding action taken to the appellant with a copy to the Commission, before the next date of hearing.

2. The representative of the respondents places a copy of letter dated 22.5.2019 vide which they have transferred application of the appellant to the Additional Chief Secretary to Government of Punjab, Department of Animal Husbandry , Fisheries and Dairy Development, Chandigarh for providing information regarding points at Sr. No.1 to 4, 5(i) 7

and 8 directly to the appellant. It is further mentioned that Sr. No. 5(ii) and Sr. No.6 the appellant was asked to inform public interest under Section 8(1) (e) of the Right to Information Act, 2005. He further states that the appellant has not conveyed any facts to establish the public interest, in response to the abovesaid letter. He further states that information relating to their office has been supplied vide their letter dated 4.12.2019 except on the abovementioned points and nothing has been left which could be supplied to him .

2. The appellant has sent an e-mail stating that he has not been provided information regarding point at Sr. No. 1 to 4, 6(ii), 7 and 8 of his RTI application

3. After hearing both the parties and going through the record available on the case file, it is revealed that no public interest has been shown regarding seeking information from the Finance Department relating to points at Sr. No. 5(ii) and 6 in his e-mail. No information relating to Finance Department is pending which could be supplied to him as per his application for seeking information under the provisions of RTI Act, 2005. Accordingly, the Finance Department is exempted from further appearance in this case. The Finance Department has sent application for seeking information concerning points at Sr. No. 1 to 4, 5(i), 7 and 8 to the Additional Chief Secretary to Government of Punjab, Department of Animal Husbandry, Fisheries and Dairy Development, Chandigarh for supplying the information to the appellant. Hence, PIO/Additional Chief Secretary to Government of Punjab, Department of Animal Husbandry, Fisheries and Dairy Development Is impleaded as a necessary party with the direction to take appropriate action regarding points mentioned above and intimate the appellant with a copy to the Commission before the next date of hearing.

ORDER

This order may be read with reference to the previous order dated 05.11.2019 vide which the respondents were directed to supply appropriate reply, whether these firms are duly authorized for on line registration as mentioned in RTI application of the appellant or not.

2. The appellant states that no information has been provided to him till date after the previous order.

3. The representative of the respondents places on record of the Commission a copy of letter dated 17.12.2019 stating that Shri Amrik Singh, Assistant Transport Officer-cum-PIO o/o Secretary, State Transport Authority Hoshiarpur was deputed to visit the premises of the firms, in question, to adjudge their genuineness. The firms told the PIO that they are sub-dealers of the authorized dealers of manufacturing companies. They further mentioned in the letter that they failed to show any satisfactory document from which it can be established that they are even authorized sub dealers for selling new vehicles.

4. After hearing both the parties and going through the record available on the case file, it is revealed that information, as sought by the appellant, has been supplied as per the provisions of the RTI Act, 2005 and nothing more can be done by the State Information Commissioner, Punjab. A copy of the letter mentioned above is sent to the appellant for taking further necessary action in the matter at his own level. Hence, the present case is disposed of and closed. Copies of the order be sent to the parties.
