*“Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, lending and borrowing, etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive.”*

4. The Commission concurs with the PIO's decision to withhold the information under Section 8(1)(j) of the RTI Act, 2005. There is no further cause for action and the Appeal is **Disposed of**.

from the PIO o/o **XEN, Punjab Water Supply & Sewerage, Moga**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **28.4.2023**. Notice was issued to the parties for first Hearing in the Commission on **19.12.2023**.

2. Both parties are absent. The respondent PIO provided a reply to this RTI application Dated nil vide Letter No. 1002 Dated 20.11.2022, advising the appellant on how to rectify the sewerage connection of her house after seeking permission from the department. The PIO has also submitted a reply to this Commission's Notice of Hearing vide Letter No. 612 Dated 3.8.2023, wherein he has reiterated that a reply was sent to the complainant on how she can get the sewerage line of her house rectified.

3. The Commission has examined the PIO's reply to the complainant and is satisfied that there is no malafide intent on the part of the respondent PIO in delaying / denying the information. The Complaint is accordingly **Disposed of**.
