- 2. The appellant has sent an Email in the Commission mentioning therein that due to some unavoidable circumstances, he is unable to attend today's hearing in the Commission.

Pollution Control Board, Patiala, by way of crossed Cheque/Demand Draft in the

name of Sh. Sukhwinder Singh within one month.
