



- 2. The appellant is absent without intimation. The respondent PIO, represented by Sh. Harpal Singh, Junior Assistant, has submitted copy of a reply sent to the appellant Vide Letter No. 73863 Dated 18.05.2023, wherein he was informed regarding the re-planning for the plot cited in the RTI application, along with the copies of the related letters written to the District Town Planner, SAS Nagar.
- 3. This RTI application has been adequately addressed by the PIO. There is no further cause of action. The appeal is accordingly, **Disposed of.**
