as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **04.03.2023** and Second Appeal was filed in the Commission on **11.05.2023** under Section 19 of the Right to Information Act, 2005. The Notice of Hearing was issued to the parties for today.

2. The appellant is absent without intimation. The respondent PIO, represented by Sh. Major Singh, SDO, has submitted copy of a pointwise written reply sent to the appellant vide Letter No. 1208 Dated 28.02.2023, along with copies of the information sought by the appellant, after due attestation. The reply was examined point-by-point and found to be complete. The appellant has, in fact, been provided the information, as available in the records of the O/o XEN, PSPCL Zirakpur.

3. There is no further cause of action. The appeal is accordingly, **Disposed of.**

Attested photocopies of all notings correspondence regarding deposit of epf employee share deducted from the arrear of revised pay scales of Shri Surinder Kumar Divisional Accounts Officer Grade 1 (Retired) 2. Attested photocopy of Circular /Rules of EPF/FPF Act 1952 in which it is mentioned that if claim of an employee has been passed for payment but employer will not deposit it along with employer share till the payment is made to the concerned by the employer. 3. Attested photocopy of circular /instructions of Punjab Govt. or PWRMDC not to make the payment of revised leave encashment to retired employees.

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **24.04.2023** and Second Appeal was filed in the Commission on **15.06.2023** under Section 19 of the Right to Information Act, 2005. This case was last heard on **02.11.2023**.

2. The appellant is absent. As directed at the last hearing on 02.11.2023, the respondent PIO is represented by Smt. Rakhi, Superintendent, has submitted, a fresh reply of the point No.1 vide Letter No.3144-45 Dated 05.12.2023 which was also sent to the appellant. The appellant further contends that reply is not satisfactory. The appellant had sought the following information at point No.1:

"attested photocopies of all notings, correspondence regarding deposit of EPF Employee's Share deducted from the arrear of revised pay scales Sh. Surinder Kumar, Divisional Accounts officer (Grade-1), Retired."

3. The PIO's representative explained that revised payscale arrears from 01.01.2016 to 30.06.2021 have not been received from the Punjab Government, so there is no question of any correspondence regarding deduction of the EPF of said arrears, being available.
