The RTI application is dated **19.04.2024** vide which the appellant had sought the information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **25.05.2024** and Second Appeal was filed in the Commission on **29.07.2024** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for today i.e. **01.09.2026**.

2. The respondent PIO, represented by Shri Beant Singh, PDS, States that the identical information requested by the appellant has already been provided to him in another similar appeal case. Since both RTI applications seek the same information which was disposed of by the former SIC Shri Asit Jolly on 23.02.2024. Further, he submitted his reply during the course of hearing, which is taken on record.

3. The appellant is absent without intimation. It is also a fact that notice of hearing was sent to him through registered post but even though he is absent, which seems his absence is intentional and willful. The appellant has not submitted any written submission and nor has he opted to be present at today's hearing. The prima facie appears that the appellant does not intend to pursue the case and he has nothing to say in this regard.

4. After having the detailed deliberations with the respondent and examining the case file it is observed that the RTI application in this case is identical as in Appeal Case No. 4996 of 2023, which was disposed of by the bench of former SIC Shri Asit Jolly on 23.02.2024. The appellant is cautioned against filing repeated RTI applications and second appeals seeking the same information over and over again. Such appeals are liable to be dismissed without hearing.

5. Keeping in view of the above, the appeal is accordingly **disposed of and closed**. Copy of the order be sent to the parties.
