4. After perusal of the documents and having detailed deliberations with the parties concerned, the appellant is unable to justify his claim to get the information.
5. Also, in accordance with the provisions of the RTI Act, the respondent authority has not to collect/collate the information and is also not bound to supply the Voluminous information as the information available on record has already been supplied. Therefore, the request to get the information is not sustainable in the eyes of law.
6. Further, the respondent PIO has sent a reply signed by Arshpreet Kaur, PIO-cum-Naib Tehsildar to the show-cause issued to her vide orders dated 20.02.2026, which is taken on record.
7. After going over the reply dated sent by the respondent PIO and found that the explanation given by her is genuine, hence, the show cause issued to her vide orders dated 20.02.2026 is **dropped.** As such, the instant appeal-case is **disposed and closed.** Copies of the order be sent to the parties.
