Nevertheless, in the interest of natural justice, **last opportunity** is granted to the appellant to file her submissions, if any, in response to the reply given vide letter no. 530 dated 28.07.2025 through which she was intimated that the information sought is regarding "Ludhiana Auto and Tractor Parts", 1149, Street 11/5, Daba Road, Kabir Nagar, Ludhiana and it is not registered under Factories, Act 1948.

4. Both the parties are directed to remain present on the next date of hearing so that facts of this case could be cleared, failing which the case will be decided on merit, ex-parte and no further adjournment will be given in this case.

5. With this, the case is **adjourned to 10<sup>th</sup> September, 2026 at 11:00 A. M.** for hearing at Chandigarh. Copies of the order be sent to the parties.
