ORDER

1. The matter is taken up today in **continuation of the Commission's order dated 02.12.2025**, whereby the PIO was directed to pay compensation of **Rs. 5,000/-** to the appellant by way of **Demand Draft** and submit a compliance report.

2. Today, **both the parties are absent**. However, an **email dated 28.12.2025 received from the appellant**, taken on record, states that the compensation amount has **not been received till date**.

3. It is evident that the **PIO has failed to comply** with the Commission's clear directions. Accordingly, the **PIO is directed, as a last opportunity**, to ensure payment of the compensation amount of **Rs. 5,000/-** to the appellant strictly in terms of the order dated 05.01.2025 and to submit proof of compliance before the Commission within the stipulated time. Failure to comply shall invite **appropriate action under the RTI Act, 2005**, without any further notice.

3. With this, the case is **adjourned to 24.02.2026 at 11:00 A. M. for hearing at Punjab State Information Commission, Red Cross Building, Madhya Marg Sector 16, Chandigarh.**
