5. Before stating anything further, it would be significant to reproduce the contents of the RTI application itself, which are as follows:-

Under the guidance of DGP Punjab, a recruitment was conducted in Bureau Of Investigation wing of Punjab Police. It was consisting of Civilian Support Staff, and in that 120 posts were advertised for the post of Assistant Legal Officer(ALO). On the basis of advertisement, exam was conducted and after the declaration of merit list, the selected candidates joined on the said post. That out of these 120 ALO posts, 02 posts were reserved for General Sports person Category.

I want the following information in concern with these 02 posts of sports person general category-

1. That, whether the above stated 02 seats are occupied at this point of time. If yes, then please state the name of those 02 candidates who are holding these posts at this point of time.
2. That, if any of these 02 posts or both are not consumed/ occupied at this point of time, then please state the reason of its being lying vacant i.e. either due to non-joining of the candidate or due to resignation by the candidate after joining on the said post of sports person general category.
3. That if any of these 02 posts is lying vacant due to the reason of resignation given by the candidate, then please state the date from which the said post is lying vacant.

Further, the respondent has filed the copy of the information provided to the appellant as under:-
