City, who appeared in today's hearing, has submitted a reply vide letter no. 07 dated 01.01.2026 and intimated that the information sought can not be supplied as it is exempted from disclosure under clause of Section 8 (i) (j) of the RTI Act. It is taken on record. The same alongwith annexure is taken on record.

3. The appellant, Sh. Bharat Bhushan, who appeared in person in today's hearing shown his dis-satisfaction over the same and requested for an adjournment so that he could file a counter reply to the response of the respondent.

4. Nevertheless, an opportunity is given to the appellant to file a counter reply, if any, and send the same to the respondent within fifteen days under intimation to the Commission.

5. The parties concerned are directed to remain present on the next date of hearing for deliberation, failing which the case will be decided on merit, ex-parte.

6. With this, the case is **adjourned to 18th March, 2026 at 12.00 Noon** for hearing at Chandigarh. Copies of the order be sent to the parties.
