ORDER:

This order may be read with the reference to the previous order dated **18.11.2025**.

2. The appellant is absent. However, an email dated 07.04.2026 has been received from him mentioning therein that directions may be issued to the respondent PIO to supply the copies of all ownership / registry or any will deed documents submitted by Alfa ITI. The said mail is taken on record.

3. The respondent PIO, represented by Shri Manga Singh, Assistant Director, Shri Balwinder Singh, Superintendent, Shri Bablu, Clerk, and Shri Gurpreet Singh, Superintendent, are present. They reiterate their earlier submissions and states that the information available on record has already been supplied and nothing further remains to be disclosed in the matter. Further, he states that the copy of registry will be provided by the tehsildar office.

4. After hearing the respondent and going through the case file, it is observed that at the last hearing the appellant was directed to appear in person and state his case. However, the appellant has again failed to appear in person before the Commission, despite specific directions issued in the last order. Further, the appellant is directed to file a fresh RTI application to the concerned PIO, to seek the requisite information.

5. Keeping in view of the above, the Commission is of the view that no further cause of action is left in this case. Hence, this case is **disposed of and closed**. Copy of the order be sent to the parties.
