This order may be read with the reference to the previous order dated **25.06.2026**.

2. The appellant, Shri Sudhir Chadha, reiterated that the sought information has not yet been provided to him.
3. The respondent PIO, represented by ASI Dharminder Singh, states that the information sought by the appellant in the initial RTI application has already been processed and is officially shown as disposed of on the UID portal. He states that the erstwhile UID portal has been official no longer operational. Further, he states that the public grievance and data management operations have shifted entirely to the new PGD Portal, which is currently active and operational. The respondent states that the permanent closure of the legacy UID portal, the specific printout requested cannot be generated. The matter stands disposed of on the records of the department.
