ORDER:

The RTI application is dated **24.06.2023** vide which the appellant has sought the information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **19.08.2023** and Second Appeal was filed in the Commission on **20.11.2023** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for today i.e. **14.10.2025**.

2. The respondent PIO, represented by Shri Amarjit Singh, SA, files a reply to the Commission's Notice of Hearing vide letter no. 3776 dated 30.09.2025, mentioning therein that a reply has already been provided to the appellant on 17.07.2023, relevant portion of the same is reproduced below:
