3. The respondent is absent, but an email dated 15.07.2025, has been received from him mentioning therein that the complete sought information has already been supplied to the appellant. The letter explained that the delay occurred due to staff shortages and an excessive workload. The PIO assured that such delays would not recur and requested the Commission to waive the penalty of Rs. 10,000.00 (imposed on PIO vide Order dated 11.05.2023) and dispose of the case.

4. After considering the above facts it noted that the RTI application has been adequately addressed, and sufficient hearings have been conducted to consider this case. Moreover, the Commission issue a warning to the PIO to handle RTI applications promptly and to avoid delays in the future and accordingly, the penalty is hereby **dropped**.

5. In view of the above, and considering the over-pendency of cases in the Commission, the case is **disposed of and closed**. Copy of the order be sent to the parties.
