**ORDER**

This order may be read with reference to the previous order dated 20.11.2025 vide which the appellant was advised to send the copy of original complaint to the respondent PIO O/o S.S.P., Bathinda, within a week from that day (20.11.2025), under intimation to the Commission.

2. In compliance to the order dated 20.11.2025, D.S.P., Sh. Amritpal Singh Bhatti, appeared in person with A.S.I., Sh. Resham Singh O/o S.S.P., Bathinda. Sh. Narinder Singh also appeared from O/o D.G.P., Punjab, Chandigarh in today's hearing.

3. The representatives of the respondent PIO from office of S.S.P., Bathinda have submitted a reply vide letter no. 391 dated 12.02.2026 and intimated that the appellant has not sent the copy of original complaint to the respondent PIO O/o SSP, Bathinda inspite of the directions passed vide orders dated 20.11.2025 by the Commission. They also submitted that the appellant was contacted time and again with the request to provide the complaint regarding which information has been sought but she has not given any positive response.

4. On asking of the Bench, the appellant, Ms. Alka, who attended today's hearing through CISCO Webex, has not given satisfactory reply/reason for non supply of the said complaint to the PIO O/o S. S. P., Bathinda.

After perusal of the case-file, it emerges that the appellant has sought information regarding status of her grievance 7309/SCI/PIL(E)/2022 dated 07.02.2022 registered with Supreme Court of India and forwarded to S.S.P., Bathinda on 14.09.2022 for 'taking necessary action and submit report to Supreme Court of India'. And the respondent PIO has submitted replies time and again stating that no such letter(as mentioned above) has been received in their office directly from Supreme Court of India and they have taken action on the said letter, which was received from the office of D.G.P., HQ, Punjab Chandigarh and complete final report in response to the RTI application has already been submitted before the Commission as well as the appellant, number of times. Through the reply dated 12.02.2026, they also submitted that a departmental enquiry has been initiated against the erring official for such delay. Further, it has also come into the notice that in the interest of justice, the appellant was advised to send the complaint to the respondent's office but she has not sent the said complaint .

6. As the appellant has not taken cognizance of the order dated passed by the Commission and also after going through the reply dated 12.02.2026, submitted by the respondent and considering the contents of the reply of the respondent and finding it satisfactory, no further directions are required to be given in the instant appeal case.

7. In view of all the above, no further proceeding is required in this case and the instant appeal-case is **disposed and closed**. Copies of the order be sent to the parties.
