ORDER:

This order may be read with the reference to the previous order dated **13.03.2026**.

2. The appellant states that no information has been given to him so far. He further requests that penalty be imposed upon the respondent PIO for delaying the information and also requests compensation for harassment.

3. The respondent, PIO-cum-ATO, Ms. Kamlesh Kumari, states that the requested information was in the custody of the MVI. Further, she states that multiple letters were written to the concerned MVI, the MVI had not cooperated or provide the requested information to the appellant.

4. After hearing both the parties and the statement given by the respondent, the Commission impleads the MVI O/o RTO, Jalandhar, Shri Narinder Singh, as a deemed PIO in this appeal case. Shri Narinder Singh, is directed to supply the requested information to the appellant through registered post within 20 days after receipt of this order, under intimation to the Commission, failing which stringent action will be initiated against the respondent PIO-cum-MVI, Shri Narinder Singh, as per the provisions of the RTI Act, 2005.

5. Ms. Kamlesh Kumari, is directed to file a reply to the Show Cause Notice issued to her vide Commission's order dated 23.09.2025.
