As per the Supreme Court decision in **KhanapuramGandaiahvs Administrative Officer &Ors on 4 January, 2010 in SPECIAL LEAVE PETITION (CIVIL) NO.34868 OF 2009** the definition of information as given under Section 2(f) of the RTI Act 2005, shows that an applicant under Section 6 of the RTI Act can get any information which is already in existence and accessible to the public authority under law. Of course, under the RTI Act an applicant is entitled to get copy of the opinions, advices, circulars, orders, etc., but he cannot ask for any information as to why such opinions, advices, circulars, orders, etc. have been passed. The appellant has expressed his satisfaction over the same.
