## ORDER

This order may be read with reference to the previous order dated 06.05.2026.

2. The appellant is absent but has sent the written submissions in this case, which are taken on record and the relevant portion of the same is as follows:

1. That the applicant/appellant most respectfully submits that the order passed by this Hon'ble Bench has been received by the applicant. 2. That it has further been recorded in the order that: "the appellant was directed to inspect the record to get the information but the appellant has not come to the office for inspection, therefore nothing has been supplied to the appellant."

However, during the course of hearing dated 05/05/2026, no such statement or direction was made in the manner so recorded. Rather, the applicant had specifically submitted before this Hon'ble Bench that PIO Kuldeep Singh and other person had stated before the Court that a vigilance inquiry/investigation relating to the matter was pending and, on that ground, the record could not be supplied to the applicant. The applicant had already placed the said facts on record through earlier written submissions as well.

Further, the applicant has no objection whatsoever in inspecting the relevant record in the concerned office/department. However, since the matter pertains to alleged robbery/misappropriation/embezzlement, the applicant respectfully seeks appropriate protection and assurance regarding his safety and security during the inspection process, so that no harm or threat is caused to the life and property of the applicant.

3 That the applicant further respectfully submits that he shall not be in a position to attend the hearing dated 21/05/2026, as certain matters concerning the applicant are already fixed before the learned Sessions Judge Courts at Amritsar on the same date.

It is, therefore, most respectfully prayed that the presence of the applicant through the present application may kindly be marked and the matter may kindly be adjourned by granting a short date for the next hearing, in the interest of justice.

Any other relief deemed fit and proper in the facts and circumstances of the case may also kindly be granted in favour of the applicant/appellant.
