2. At today's hearing, the appellant states that despite the lapse of considerable delay, the complete and correct information has not been given by the respondent PIO, so far. However, queries seeking justification, clarification, or reasons not available on official records do not fall within the ambit of "information" as defined under Section 2(f) of the RTI Act, 2005.

5. Accordingly, no further intervention of the Commission is warranted in the matter. The appeal is **disposed of and closed**. Copies of the order be sent to the parties.
