The respondent present made the submissions that the Builders are selling the plots without mentioning the khewat number/khatoni number and also no such type of details are being entered in the registry of the flat so the department is unable to provide such details related to the said Mega Project i.e. Omaxe, New Chandigarh.

4. In light of the oral submissions made by the respondent, he is directed to file the detailed written reply with regard to the RTI application on/or before the next date of hearing. He is further directed that the copies of act/Rules be also submitted according to which the registry of flat is being registered.

5. On asking, whether the said builder has the said information.
