1. This order may be read with reference to the Commission's previous order dated **29.01.2026**.
2. Today, both parties are present. The appellant, **Sh. D.R. Singla**, is present. The respondent, **Ms.PritpalKaur (Data Entry Operator)**, has submitted a reply vide letter Ref. No. **2167 dated 21.04.2026**, furnishing point-wise information. It has been stated, inter alia, that the office was open on **11.01.2023**, was not closed on that date, the query regarding attendance is **not clear as to the category of employees**, and that the **CCTV cameras were not in working condition**.
