4. Nevertheless, another opportunity is given to the respondent PIO to supply the required information to the appellant / file a proper reply (in response to the RTI request) before or on the next date of hearing.
5. Sh. Gurjit Singh, Superintendent-cum-PIO has also submitted a reply dated 30.10.2025 in response to the show cause issued vide orders dated 17.09.2025.
6. A decision on the reply filed by Sh. Gurjit Singh in connection with the show cause issued, will be taken later on.
7. With this, the case is **adjourned to 24<sup>th</sup> February, 2026 at 12.00 Noon** for hearing at Chandigarh. Copies of the order be sent to the parties.
