### **ORDER**

The RTI application is dated 26.03.2025 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 16.07.2025 and second appeal was filed in the Commission on 18.12.2025 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for today i.e. 23.12.2025.

2. The appellant has sought an action taken on the letters dated 05.04.2024, 16.05.2024, 09.09.2024 and 07.10.2024. But none is present on behalf of the respondent PIO. It is also a fact that a notice of hearing was sent to the parties through email and also for the convenience of the parties, the case was fixed for hearing through Cisco Webex but in-spite of that the respondent remained absent without intimation.

3. Viewing the attitude in dealing with the RTI application by the respondent casually, **Dr. Satinderjeet Singh, Civil Surgeon-cum-Public Information Officer**, O/o Civil Surgeon, Amritsar, is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay/denial of the information to the RTI applicant and to show cause why a compensation under section 19(8) of the RTI Act, 2005, may not be paid to the appellant for causing willful delay/denial of the information for detriment suffered by him.
