**ORDER:**

1. The appellant has filed the above-mentioned appeal before the Commission, which was fixed for hearing today.
2. **Respondent:**Ms.MadhuBala (Superintendent) and Ms.Jyoti (Junior Assistant) appeared and submitted that the RTI application was duly examined and it was found that no information, as sought by the Appellant, is available on the official record. It was further submitted that a clear reply vide letter No. 24034 dated 23.12.2025 was issued by the PIO to the Appellant, wherein the non-availability of the information on record was specifically conveyed.
3. **Appellant:** Sh. George Subh appeared and submitted that the Respondent is deliberately concealing the relevant files and is not providing the correct information. He alleged that misleading facts have been placed before the Commission.
4. The Commission has carefully considered the submissions of both the parties and perused the material available on record. The Commission observes that the scope of the Right to Information Act, 2005 is limited to providing access to information as is available and existing on the record of the public authority. The Act does not cast any obligation upon the PIO to conduct an investigation, draw inferences, or verify allegations made by the Appellant.
5. In the present case, the Respondent has categorically stated, both orally and through the written reply dated 23.12.2025 that the information sought is not available in the records of the public authority. Mere allegations of concealment, in the absence of any supporting material, are not sufficient to hold that the information has been withheld.
6. In view of the above facts and circumstances, the Commission finds no infirmity in the reply furnished by the PIO. Accordingly, the appeal is **disposed of**, with no further directions.
