ORDER:

This order may be read with the reference to the previous order dated **28.01.2026** vide which an inspection was given to the appellant.

2. The appellant states he has not received information from the respondent to date. The appellant further objects to the inspection on the grounds that it was ordered in his absence, stating that he was not present when the order was made. Further, he refused to visit the office of respondent for inspection.

3. The respondent PIO, represented by Shri Chashpinder Singh, Clerk, states that the reply has already been sent to the appellant. Further, he states that in compliance with the directions issued during the last hearing, the appellant was invited to inspect the relevant records on two separate occasions. However, the appellant explicitly refused to avail himself of this opportunity. The respondent further submits that nothing more is available in the official record which could be supplied to the appellant and requested to close this case.

4. After having detailed deliberations with both the parties, the Commission notes that the appellant has failed to comply with its explicit directions to inspect the records. The Commission rejects the appellant's claim that he was absent when the inspection was ordered. A perusal of case file shows that he attended the previous hearing, and his presence was officially marked in that order. Conversely, the respondent made genuine efforts to facilitate transparency by
