1. The respondent **<u>PIO-cum-XEN</u>**, **Zone A**, **B**, **C**, **and D**, **MC**, **Ludhiana**, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **2.11.2020**.
