ORDER:

1. This order may be read with reference to the Commission's previous order dated **03.02.2026**, whereby **compensation of ₹5,000/-** was awarded to the appellant under **Section 19(8)(b) of the RTI Act, 2005**.
2. The matter is taken up for hearing today. Both parties are present and heard. The respondent, **Sh. Rajinder Singh, GRS**, submitted a written compliance vide letter Ref. No. **1460 dated 02.09.2026**, stating that the information available on the official record has been furnished and **nothing further is pending**. A copy thereof has been handed over to the appellant.
3. The appellant remains dissatisfied and alleges that the respondent is misleading him. **However, the Commission's jurisdiction under the RTI Act is confined to providing information available on the record and does not extend to adjudicating disputed facts, verifying the correctness of records, or conducting an independent enquiry into such allegations.**
4. In view of the compliance submitted and the limited scope of proceedings under the **RTI Act, 2005**, **no further intervention is warranted. Accordingly, the appeal is DISPOSED OF.**
