ORDER:

3. **Sh. Baljit Singh Sohi, PIO** has submitted his reply to the Show Cause Notice vide **Memo No. 384 dated 18.08.2026**. The respondent requested some more time to address the deficiencies pointed out by the appellant.
4. In view of the compliance shown and the request made, the **Show Cause Notice issued under Section 20(1) of the RTI Act, 2005 is hereby dropped**.
5. The respondent is directed to **make good the deficiencies and furnish complete, correct and point-wise information** to the appellant within **15 days**, under intimation to the Commission.
