ORDER

The RTI application is dated 11.12.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 10.01.2024 and second appeal was filed in the Commission on 11.03.2024 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for today i.e. 26.08.2026.

2. The appellant sought the following information:

“Jai Hind Sir, Investigation of DDR No. 19 dt 13 Oct 2022 has already been carried out by SP Sh. Tarun Rattan Rupnagar and pending at SSP Rupnagar vide UID No. 228733. Request forward the same for our further necessary action.”

3. The appellant submits that the directions may be issued to the respondent PIO to supply the complete sought information. However, the respondent submits that the appellant was called for inspection of the official record pertaining to the RTI application.

4. After having detailed deliberations with both the parties, the **Station House Officer (SHO), Thana Sadar, Nangal, is directed to remain present, in person**, on the next date of hearing along with the original record pertaining with the DDR No. 19 dated 13.10.2022. Also, he is directed to bring the status report of the same, to take the matter to its logical end. The respondent, **Sh. Sardul Singh, ASI, is also directed to appear, in person**, on the next date of hearing along with the said Station House Officer.
