The following issues were discussed and decided:-

Item No.1-

At the outset the State Information Commissioners namely; Sh. Yashvir Mahajan and Shri Nidharak Singh Brar who has recently joined the State Information Commission w.e.f. 23.04.2015, were given rousing welcome by all the existing members and assured to extend full co-opration to them. It was noted as a matter of pride for the State Information Commission, Punjab that the State Government has appointed all the 10 Commissioners in addition to C.I.C. as provided under the RTI Act,2005 to take care the right of implementation of the citizens of the country.

Item No.2- Status of the new building, Sector-16, Chandigarh.

In the meeting of the Full Commission, it was clarified that the new constructed building in Red Cross Bhawan, Sector-16 in which the office of the State Information Commission, Punjab is to be shifted, is ready. The State Government has

allowed to utilize the funds lying un-used with the Health Department for interior partition of this building. The Occupancy Certificate is expected to be issued shortly by the Estate Office U.T.Administration.Thereafter, necessary partition etc. work will be carried out. The matter regarding rent for the new building was also dicussed and the members were apprised of the proceedings of the meeting recently held on the subject.

Item No. 3 -

Regarding views and suggestions for the web site of the State Information Commission, Punjab.

The web site of the State Information Commission i.e. infocomm.punjab.com which is working since the inception of the Commission , needs some changes for which all the Commissioners are welcome to offer their valuable views and suggestions for improvement of the web site. On the receipt of the views and suggestions for improvement of the exisiting web site it will be given practical shape. For this purpose a sub committee has already been formed under the chairmanship of the Hon'ble CIC.
